

Summary of Board Action Taken on September 11, 2020: On September 11, 2020, and pursuant to Governor Ivey's March 2020 proclamations, the Alabama State Board of Chiropractic Examiners held a regular meeting and discussed a need to respond to COVID-19 by adopting the following emergency rule deemed necessary for the public's health, safety and welfare, which provides the Board the authority to revise continuing education requirements set forth at Administrative Code Sections 190-X-2-.11 during a Governor declared state of emergency. The Board did not foresee the state of emergency would continue, therefore, this emergency rule was adopted. This emergency rule was adopted at this September 11, 2020 Board meeting that convened at 8:40AM and adjourned at 10:12AM and is available for review below:

For the next 120 days and only for the 2020-2021 Renewal cycle all eighteen (18) hours of required continuing education for licensure renewal may be satisfied by distance based continuing education.
