

**465-X-2-.06 Roster of Licensees.** The Board shall publish, electronically or otherwise, by March 31 of each year a complete roster of all licenses issued and renewed for that calendar year. The board ~~shall not provide mailing lists of licensees upon request while the roster is available.~~ may provide mailing lists of licensees to only approved continuing education providers, who have signed an agreement restricting the use thereof to solely dissemination of approved continuing education course information.
