RULE)**

(1) § 40-17-168.11, Code of Ala. 1975, requires persons to file the CNG/LNG Alternative Fuel Monthly Tax Return electronically through the department's electronic filing system.

(2) The CNG/LNG Alternative Fuel Monthly Tax Return will be considered timely filed when due if filed electronically by the last day before the return or report is considered delinquent. The amount due with the return will be considered timely paid if paid in accordance with the rules of the electronic funds transfer provider.

(3) This regulation will become effective on October 1, 2018, to coincide with the effective date of Act 2017-229.
