

INTENDED ACTION: The Alabama Board of Funeral Service proposes to add new rules as Rule No. 395-X-4-.04 titled "Managing Funeral Director", Rule No. 395-X-4-.05 titled "Business Cards", and Rule No. 395-X-4-.06 titled "Records".

SUBSTANCE OF PROPOSED ACTION: The Board proposes to add new rule Rule No. 395-X-4-.04 titled "Managing Funeral Director" to clarify that the managing funeral director must live within 75 miles of the establishment from the physical address of the establishment to the physical address of the funeral director's residence. The Board proposes to add new rule Rule No. 395-X-4-.05 titled "Business Cards" to require the job title of an individual be listed on an establishment business card. The Board proposes to add new rule Rule No. 395-X-4-.06 titled "Records" to require all records required by the funeral law be kept on site of the funeral establishment.


