30-X-2-.01 **Meetings Quorum.** ~~A~~The annual meeting of the Board for the election of officers for the ensuing year shall be held ~~during the month of November in each year~~annually. Other regular meetings shall be held in January, May, and September, and special meetings shall be held on call of the Chair or on request of three or more members of the Board. A majority of the Board shall be a quorum and may exercise the powers and perform the duties devolving on the Board, except for actions taken under authority of Section 3 of the Act, which restricts action to the Board members who are Certified Public Accountants, in which case three members who are Certified Public Accountants shall constitute a quorum to transact business.
