
INTENDED ACTION: The Alabama Board of Nursing proposes to amend the rules relating to public records and rosters.

610-X-1-.11 Public Records And Rosters.

(1) The minutes of the Board, except those portions authorized by law to be kept confidential, and the name and address of licensees shall be open to public inspection.

(2) Members of the public who wish to either examine or duplicate a public record(s) may do so in accordance with the following:

(a) The examination or duplication of a public record(s) shall be in the office of the Board and under the supervision of the executive officer or an authorized designee.

(b) A fee shall be assessed for the cost of duplication.

~~(3) A roster of names and addresses of licensees is available for purchase. Any request for purchase of the public roster of licensees shall be submitted online on the Board's web site.~~

~~(4) Materials to be disseminated shall not be published in a manner which could be construed by the public to mean that the Board supports, endorses, approves or the materials.~~

~~(5) Purchaser shall not release or sell the roster to a third party.~~
